Other Provisions

In case of an emergency, I hereby give my permission to chaperones of the Outdoor Adventure Program Trips or medical staff selected by Saint George's School to administer appropriate treatment and/or injection, anesthesia, surgery, or any treatment deemed reasonably necessary or beneficial for myself or my child named above. All costs associated with medical services, including evacuation, shall be borne by me.

Saint George's School may use the services of private contractors for certain tasks including, for example, transportation. Saint George's School is not responsible for the acts or omissions of such contractors.

I agree to hold harmless and indemnify St. George’s School for any and all liability, claims, or demands for any injury, sickness, or death as well as property damages and expenses of any nature whatsoever sustained by St. George’s School as the result of the negligent, willful, or intentional acts of myself or my son or daughter, including expenses incurred attendant thereto. Saint George’s School is not responsible for loss, theft, or damage to a student’s personal belongings at any time during the activity, including storage by chaperones or others. The waivers, releases, hold harmless provisions, assumptions of risks and liability, and indemnification above shall be construed broadly to the maximum extent permissible under applicable law.
